Meet the Presenters...

Gail Bennett, RN, MSN, CIC

Gail has been involved in infection control for 26 years. She is the Executive Director of ICP Associates, a national consulting firm in Rome, Georgia. She has authored three chapters of the APIC Curriculum for Infection Control Practice (1983), a chapter in the APIC Text (1996) on consulting, a chapter in the APIC Text—Principles and Practice on Consulting (2000), two manuals for infection control and multiple articles for journals. She serves as a motivational and educational speaker in numerous states each year. Gail will identify issues affecting infection control programs in long-term care facilities including multi-drug resistant organisms, hand hygiene and the 2005 isolation guidelines as well as practical approaches to deal with them.

Joann Schaefer, MD

Dr. Schaefer currently serves as the Deputy Chief Medical Officer for Nebraska's Health and Human Services System and is a tenured associate professor at Creighton University Medical Center in the Department of Family Practice where she yielded many assignments including establishing clinical practice in the Old Market, covering student health, resident teaching and finally relocating her clinical practice to the Eagle Run location where she continues to see patients despite her many other appointments. Dr. Schaefer received the "Physician of the Year Award" in 2004 through the Nebraska Medical Association. She was involved in the state-wide response and vaccination plan for smallpox. She will share her expertise on the topic of influenza, including vaccine strategies, pandemic vs. yearly outbreaks, surveillance in long-term care and anti-viral treatments.

Sue graduated from Anderson University in Indiana where she earned degrees in both Nursing and Sacred Music.
